

ANTI-COVID PROCEDURES FOR DORMITORY RESIDENTS
DURING AN EPIDEMIC EMERGENCY SARS-CoV-2.

1. Checking-in

- Accommodation in the dormitory can only be guaranteed to a person not exhibiting symptoms of illness indicating the risk of COVID-19, such as fever, cough, joint and muscle pain, among others. Persons showing symptoms of infectious respiratory illness, for health safety reasons, are asked to remain in their current residence/accommodation until the symptoms have resolved completely.
- In view of the obligation to vaccinate pertaining to students studying courses preparing for the medical profession introduced by the provisions of the Decree of the Minister of Health on the declaration of an epidemic emergency in the territory of the Republic of Poland of May 12, 2022 (Journal of Laws of 2022, item 1028) - the aforementioned students are asked to show the certificate of their full vaccination at the check-in .
- Persons who cannot check in within the referral validity period for health reasons are asked to report this to the dormitory administration. They will either be checked in remotely or the validity of the referral will be extended. In either situation, they will not lose the dormitory space allocated to them. Those who are checked in remotely are asked to report in person to the dormitory administration after their full recovery to complete the formalities of accommodation.
- Checking in late does not exempt the resident from paying the rent from October 1.
- Before entering the dormitory building, students are asked to observe hand disinfection with disinfectant provided by the administration.

2. Daily operation of the dormitory

To ensure health safety in the dormitories, only the visitors who voluntarily show proof of their full vaccination to the receptionist will be allowed to enter the dormitory premises.

- Students and visitors are asked to use the disinfectant liquids placed at the entrances to the buildings, at the reception desk and by the entrances to the common areas.
- When using facilities such as public benches, barbecues, bicycle sheds, or smoking areas on the dormitory premises, residents are asked to observe the sanitary regime rules in effect at the time.
- All common spaces are open for use, however, for health safety reasons, residents are asked to observe the sanitary regime rules in effect at the time.
- Persons who do not comply with the aforementioned recommendations should expect consequences as determined by the Residents' Council.

3. Isolation

A dormitory resident exhibiting medical symptoms indicating a risk of COVID-19 infection:

- is asked to immediately report this by phone to the dormitory administration and contact their primary care physician, who will decide whether a smear for SARS-CoV-2 infection is necessary.
- The person will be placed in temporary isolation in a room designated for this purpose.

A dormitory resident with a positive result confirming SARS-CoV-2 infection

- If a student receives a positive test result confirming SARS-CoV-2 infection, they should immediately report this fact to the dormitory administration by telephone.
- Persons undergoing isolation are asked not to leave the designated isolation room.

Any violations of the above rules will be reported to the Resident Council for consideration. This procedure is subject to change to comply with the current rules and restrictions resulting from the mandatory laws enacted in the Republic of Poland.
